## **Orientation & Training Policy for New MLS-Only Members**

MLS Rules and Regulations, Section 17 states, "Any applicant for MLS Participation and any licensee affiliated with an MLS Participant who desires access to MLS-generated information shall complete an orientation program of no more than eight (8) classroom hours devoted to the MLS Rules and Regulations, and computer training related to MLS information entry & retrieval and the operation of the MLS within ninety (90) days after access has been provided."

Therefore, all new MLS applicants are <u>required</u> to complete the course "MLS Orientation", which is a review and discussion of local MLS rules & regulations. Active REALTORS® in compliance with their primary association may request a waiver for this course after activation of membership.

Failure to comply with this ruling in a timely manner will result in the new applicant being suspended and eventually dropped from consideration by the Association. Reapplication to the Association will require payment to the Association of new application fee in the amount equal to the original fee. The Board of Directors upon applicant's request will consider exceptions on an individual basis.
