A letter of good standing from the agent's MLS if the MLS is not directly through the Association.

A letter from Broker/Participant noting the agent is authorized to apply and hold MLS-Only status in our Association's MLS.

A copy of the agent's FREC license.

A headshot photo suitable for business and provided as a .jpg or .png file

**NOTE: If interested in a Sentrilock lockbox account, the activation fee \$50.00 and the annual usage fee is \$144.00. Usage fees are not prorated.**

The following notes apply to all MLS users:

- Note 1** All payments must be made by Broker/Participant or from the Company; VISA and MasterCard are accepted, must be present at time of transaction; all fees are Non-refundable
- Note 2** Brokers active as MLS Participants are billed MLS Access Fees at the rate of \$218.70 biannually (every 6 months eff. 4/1/24) times the number of active users including the broker; MLS Access Fees are prorated for new members at application; at no other time are these fees prorated. The initial fee for a new MLS Participant is \$1,000 per participant / office.
- Note 3** REALTOR membership and active MLS usage must be maintained at all times with the broker's and/or agent's local association and/or MLS.
- Note 4** The participant to our Association must be the firm's broker of record or is an active broker associate responsible for daily operations concerning the Indian River County area.
- Note 5** All new MLS Participants and Users must attend a 2-hour MLS Orientation program and a 2-hour MLS Computer training class within 90 days of application at the Association office.
- Note 6** Sentrilock lockbox cards and services are optional
